Quarterly Activities Report to 31 December 2024

Black Dragon Gold (ASX:BDG; "Black Dragon" or "the Company") is pleased to provide the following quarterly activities report for the period ending 31 December 2024.

Operational update

Salave Gold Project in northern Spain

Following an extensive nine-month period of consideration, a land rezoning application before the Tapia de Casariego Town Council ("Council") was rejected (refer ASX release 2 December 2024).

The application submitted and accepted by Council in February 2024 was to change the land designation use at Salave from agricultural to industrial to allow mining activity.

According to the Council, its decision to reject the application was based on prohibitive restrictions in the 2016 Urbanistic Plan ("Plan"), which are yet to be authenticated by the Company or its legal team. The Plan had previously been used by Council to approve exploration drilling at the Salave project site.

This disappointing decision comes following observations of a positive shift in sentiment around its 1.5m+ oz Salave high grade gold project in Asturias, including several pro-mining stakeholders expressing frustration at sluggish processes relating to the Environmental Impact Assessment ("EIA") progressing.

Company representatives remain in regular communication with local (Tapia) and regional (Asturias) levels of government to progress EIA approvals for the Salave Gold Project. The Company is keeping all legal and strategic options open with progressing Salave Gold.

WA exploration and tenement holding

No exploration activity was conducted at the Company's Ivan Well exploration licence (E69/3818) near Wiluna in the northern Goldfields.

Corporate update

Strategic placement completed for Spanish investors

During the quarter the Company completed a private placement of 28,481,720 CDIs at AUD\$0.025 per CDI and a 2.9% discount to monthly VWAP and 21.6% discount to 5-day VWAP. CDIs were allotted as planned on 1 November 2024.

Placement participants included a group of high net worth and sophisticated Spanish investors, raising a further AUD\$712,000 to fund ongoing operations (refer ASX release 30 October 2024).

AGM meeting and results

On 20 December 2024 the Company held its Annual General Meeting (AGM) in Perth, Western Australia. All resolutions put to the AGM were carried.

Note on ASX price query

During the quarter, the Company received a price query from the ASX on 23 December 2024 with regard to a jump in security trading activity and increase in share price. Black Dragon's Board provided a timely response to the ASX in relation to the query and trading was not impacted.

Cash position

At 31 December 2024, Black Dragon held CAD\$1,445,580.

Related party costs

During the quarter, the Company paid a total of CAD\$89,321 to related parties for Director fees and salaries.

ABOUT BLACK DRAGON GOLD

Black Dragon Gold Corp. (ASX:BDG) is an exploration company with a global portfolio of exploration assets. The Company's flagship project is Salave, one of the largest undeveloped gold projects in Europe. Salave is 100 per cent owned by the Company and located in the north of Spain in the Principality of Asturias.

ABOUT THE SALAVE PROJECT

The project has a Measured Mineral Resource of 1.03 million tonnes grading 5.59 g/t Au, containing 0.19 million ounces of gold; an Indicated Mineral Resource of 7.18 million tonnes grading 4.43 g/t Au, containing 1.02 million ounces of gold, plus Inferred Resources totalling 3.12 million tonnes grading 3.47 g/t Au, containing 0.35 million ounces of gold.

The information in this announcement that relates to the Mineral Resource estimate for the Salave project was first released by the Company in its news release entitled 'New NI 43-101 Mineral Resource Estimate Increases Resources at Salave' dated 25 October 2018.



Black Dragon confirms that it is not aware of any new information or data that materially affects the information included in the original announcement and that all material assumptions and technical parameters underpinning the estimate in the previous announcement continue to apply and have not materially changed.

A full technical report summarising the Mineral Resource estimate completed by CSA Global is available on the Company's web site (www.blackdragongold.com) and posted on SEDAR. In addition to the current Mineral Resource, historical exploration work suggests there is the potential for additional mineralisation within Black Dragon's landholdings.
