

## **MALI ASSETS UPDATE**

Marvel Gold Limited (ASX: MVL) (Marvel or the Company) refers to the announcement dated 3 April 2023 in relation to the acquisition of the remaining 20% interest in five exploration licenses located in Southern Mali that comprise the Kolondieba and Yanfolila gold projects, as well as several tenements continuous with Tabakarole that are under a joint venture with B2Gold¹ Corp (JV Exploration Licenses).

Under the acquisition agreement, the JV Exploration Licences were required to be transferred to Marvel by 26 March 2025 (**Tenement Transfer Sunset Date**). The tenement transfer has not occurred due to the ongoing closure of the Mali Cadastre and therefore, B2Gold and Marvel have agreed to extend the Tenement Transfer Sunset Date to 26 March 2026.

Following the agreement with B2Gold Corp, Marvel entered into an earn-in and joint venture agreement with Resolute Mining Limited over its Kolondiena Gold Project (JV Agreement) (refer ASX Announcement dated 30 May 2023). Under the terms of the Agreement, the tenements the subject of the JV Agreement (JV Tenements) were to be transferred from B2Gold to Marvel by 26 May 2025. Due to the ongoing closure of the Mali Cadastre as referred to above, the JV Tenements have not been transferred. Marvel and Resolute have agreed to extend the timeframe to transfer the JV Tenements to 26 May 2026.
