Sprintex G15 Jet Blowers Recognised by United Nations's WIPO GREEN for Sustainable Aquaculture

Highlights:

- Sprintex's G15 Jet Blowers selected by the United Nations (UN) World Intellectual Property Organization (WIPO) GREEN for inclusion in its database of innovative climate change mitigation technologies
- Recognition highlights the G15's role in sustainable aquaculture, delivering up to 70% energy savings and supporting global environmental goals
- Acknowledgement follows CE Mark certification and strengthens strategic partnerships, including pilot projects with Fresh By Design, Pure Aquatics, SEA LIFE Aquariums, and Scylla Mud Crab In Australia, and pipeline of international opportunities

Sprintex Limited (ASX: SIX) (Sprintex or Company) is pleased to advise that its G15 Jet Blower Series has been selected by WIPO GREEN, a division of the United Nations World Intellectual Property Organization (WIPO), for inclusion in the WIPO GREEN Database of innovative climate mitigation technologies. This major milestone provides considerable validation of the Company's offering and recognition of the G15's contribution to sustainable aquaculture, reinforcing Sprintex's leadership in energy-efficient industrial solutions.

The G15 Blowers have been added to the Green Technology Book Expo 2025 collection within the WIPO GREEN Database (which is accessible at https://wipogreen.wipo.int/wipogreen-database/articles/162245). This inclusion recognises energy technologies from the Asia-Pacific region, with inclusion expected to amplify Sprintex's global reach among sustainability-focused stakeholders.

This recognition aligns with the G15's proven ability to reduce energy consumption by over 50% compared to traditional blowers, making it an ideal solution for aquaculture's oxygenation and water quality needs.

Operating at speeds up to 80,000 RPM, the G15 series — available in models such as the G15 4kW and 7.5kW (30kPa and 40kPa variants) — features a patented ultra-high-speed motor and a proprietary shaft design with a total rotor weight not exceeding 120 grams. Specialised impeller coatings and IoT-enabled real-time monitoring of temperature, pressure, and flow enhance durability and operational efficiency. These attributes support aquaculture applications like hatcheries, pond aeration, and recirculating systems, driving sustainability by minimising energy use and environmental impact.

This achievement builds on the G15's CE Mark certification in April 2024 (refer ASX announcement: 17 April 2024). In Australia and internationally. The G15's potential has been demonstrated in multiple pilot projects, including a significant trial with Fresh By Design at a well-known Queensland Prawn Farm, additional trials with Fresh By Design and Pure Aquatics across various Australian aquaculture sites, and a high-profile installation at SEA LIFE Aquarium. Internationally, Sprintex has partnered with
