

- It accelerates integration and deployment with an extensive list of plug-ins all out of the box.





The Australian market sizing and opportunity is considerable even before factoring international expansion

Growth Drivers:

• Rising Compliance Pressure:

Wage theft laws, data privacy fines, ESG reporting

• Digital Transformation:

SaaS adoption for HR, automation, and remote workforce needs

• Technological Innovation:

Al/ML integration for proactive risk detection & analytics

• Sector Expansion:

Non-financial (mining, healthcare, education) ramping up compliance.

Competitive Landscape:

- Fragmented Market: No dominant all-in-one GRC/workflow provider
- **Key Players**: SafetyCulture (A\$160M rev), Kinatico (A\$29M rev), ELMO Software (A\$91M rev), SAI360 (enterprise GRC)
- Global Suites: ServiceNow, SAP, Oracle, Workday targeting large enterprises
- **Opportunity**: Integrated platforms, user-friendly UX, niche vertical solutions

Challenges:

- Fragmentation: Siloed point solutions, tool fatigue
- Budget Constraints: SME hesitance; ROI proof is key
- Funding Environment for new entrants: RegTech funding down 50% since 2018; well-capitalized incumbents

Investment Outlook:

Short-Term:

Double-digit growth likely; demand driven by immediate regulatory deadlines

• Mid-Term:

Market matures but still healthy CAGR (10–15%); expect consolidation & advanced AI modules

• Resilience:

Compliance is nondiscretionary spend = inelastic demand

• Attractive Upside:

Large, growing market with multiple paths to scale or exit

~60-70% of TAM actively "in-market";

could reach 80–90% by 2030

SOM


1–3% share **(1-3 yrs)**; 8–10% share **A\$200–300M+ (5-10 yrs)**



Overlaying the SOM over current revenue



- New Entrant SOM
 - 1% share = **\$10m**; (Yrs 1-3)
 - 1% Share = \$25m; (Yrs 5+)
- Kinatico is not a new entrant so has acceleration potential
- Model assumes no other revenue growth
- Does not represent a forecast


