Metal Powder Works Limited – (ASX: MPW) – Anticipated Reinstatement to Quotation

Description

It is anticipated that the securities of Metal Powder Works Limited ('MPW') will be reinstated to quotation at 10:00:00am (+/- 15 seconds) AEDT on Tuesday, 11 March 2025, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

MPW raised \$10 million pursuant to the offer under its replacement prospectus dated 24 January 2025 (the 'Replacement Prospectus') by the issue of 50,000,000 shares at an issue price of \$0.20 per share.
