## Notice given under Section 708A(5) of the Corporations Act

Following shareholder approval at a general meeting held on 28 February 2025, Nimy Resources Limited (ACN 155 855 986) (**Company**) advises that on 7 March 2025 it completed the issue of 1,000,000 fully paid ordinary shares (ASX:NIM).

Further, pursuant to a Placement announced on 26 February 2025, the Company also issued 20,909,090 fully paid ordinary shares today, 10 March 2025. The Placement Shares were issued utilising the Company's existing share placement capacities (5,304,950 Placement Shares under Listing Rule 7.1 and 15,604,140 Placement Shares under Listing Rule 7.1A).

Both Appendix 2A's have been lodged today.
