## COMPLETION OF INSTITUTIONAL PLACEMENT

New World Resources Limited (**ASX: NWC**) ("**New World**" or the "**Company**") is pleased to announce that further to its announcement of 7 March 2025, it has now completed the placement of 700 million ordinary shares ("**Shares**") at an issue price of \$0.02 per Share ("**the Placement**"). The Placement was undertaken pursuant to the Company's available capacity under Listing Rules 7.1 and 7.1A.

In addition to the Institutional Placement, members of the Company's Board of Directors and Senior Management have committed to subscribe for approximately \$640,000 as part of a conditional second tranche placement, which is subject to shareholder approval to be sought at an upcoming Extraordinary General Meeting expected to be held in late April 2025.
