#### **Analysis of Consolidated Financial Results**

The Company ended the period with a cash balance of \$373,394 (2023 - \$459,039). A further \$860,910 has been raised by the Company after the balance date and prior to the date of the Half Year Report being lodged. ### **About Forrestania Resources Limited**

Forrestania Resources Limited is an Australian resources company exploring for gold, copper and lithium in the Forrestania, Southern Cross and Eastern Goldfields regions of Western Australia.

The company's Forrestania Project hosts gold, lithium and nickel prospects in close proximity to the historic Bounty gold mine, the Covalent Mt Holland Lithium Mine, and the operating Flying Fox, and Spotted Quoll nickel mines in the well-endowed southern Forrestania Greenstone Belt.

The Eastern Goldfields tenements are located within the Norseman-Wiluna Greenstone Belt of the Yilgarn Craton. In total this includes eleven Exploration Licences and four Exploration Licence Applications, covering a total area of  $\sim 1,000 \, \mathrm{km}^2$ .
