# RLF and Elders Sign Supply Agreement to Power National Market Expansion

RLF AgTech Ltd (RLF or the Company) (ASX: RLF) is pleased to announce the signing of a Supply Agreement with Elders Rural Services Australia Limited (Elders Australia), a subsidiary of Elders Limited, one of Australia's most trusted and enduring agribusinesses.

Termination	By one party giving the other party at least 14 days' notice.
