

## **GENERAL MEETING ADJOURNED**

Mantle Minerals Limited (**ASX:MTL**) ("Mantle") ("the Company") advises that it has adjourned today's General Meeting of Shareholders.

In accordance with rule 13.9 of the Company's constitution and prior to any business being conducted, the Chair adjourned the meeting at 11:03am until 11:00 am (WST) on 11 April 2025 at the same location being at Level 2, 7 Havelock Street West Perth WA. The adjourned meeting on 11 April 2025 will consider the sole resolution regarding the consolidation of the Company's capital.

The Company advises that:

- (a) all proxy forms received to date remain valid for the adjourned meeting;
- (b) in the event that a shareholder has already provided a proxy form to the Company and wishes to provide a new proxy form for the adjourned meeting, the new proxy form will revoke the earlier form provided; and
- (c) proxy voting will close at 11:00am, Wednesday 9 April 2025. The original proxy form circulated with the notice of meeting (and available through the ASX announcements platform as an annexure to the original notice of meeting) remains applicable to the adjourned meeting.
