March 2025 Quarterly Activities Report

Great Northern Minerals Limited (ASX: GNM) (**GNM** or the **Company**) is pleased to provide shareholders with its Quarterly Report for the three-month period ending 31 March 2025.

HIGHLIGHTS:

- ➤ Completion of 3rd Earn-In Stage upon receipt of cash consideration of \$1.3M from Great Eastern Gold Ltd.
- Appointment of Non-Executive Director Clarissa Chua.
- > Review of resource projects for potential acquisition.

Sale of Golden Ant Shares

On 12 February 2025, GNM announced the successful completion of the 3rd Earn-in Stage under the binding share sale agreement with Great Eastern Gold Ltd (**GEG**) and Golden Ant Mining Pty Ltd (**Golden Ant**), originally executed on 20 November 2023 and subsequently varied on 31 January 2024 and 22 February 2024 (**Transaction Agreement**).

GEG has paid the Phase 3 cash consideration of \$1.3 million to GNM, thus satisfying the 3rd Earn-In milestone and increasing its equity interest in Golden Ant by 35.5%, bringing its total holding to 63%. GNM retains a 37% interest in GAM.

GEG, a privately held Australian mining company with an experienced operational team, intends to accelerate the development of its Queensland assets toward production.

As outlined in the Transaction Agreement and the table below, upon completion of the 4th and final earn-in stage, GEG will increase its ownership in Golden Ant to 90%, with a further \$1 million cash payment due to GNM.

Project Update

During the quarter, GNM decided to withdraw its renewal applications for the Finland Lithium Projects (Kuusisuo – VA2023:0010 and Ojankylä – VA2023:0011), allowing the Company to concentrate on more strategic opportunities.

GNM continues to actively assess a number of resource projects for potential acquisition, with early-stage commercial discussions in progress.

Corporate

As at 31 March 2025, the Company held cash reserves of \$1.46 million.

Payments made to the Company's related parties and their associates during the quarter totalled \$64K, also noted under item 6.1 of the Appendix 5B, which includes the payments for Directors' fees and salaries, consulting fees and superannuation paid during the quarter.

On 30 January 2025, the Company announced the completion of a facility for the sale of ordinary shares for holders of unmarketable parcels of the Company's shares. A total of 7,354,331 shares have been sold, from 572 holders of Unmarketable Parcels, at a price of \$0.01 per share.

On 3 March 2025, the Company announced the appointment of Company Secretary, Clarissa Chua, as Non-Executive Director with immediate effect, following the resignation of Cameron McLean as announced on 6 December 2024. The Company also announced the resignation of Joint Company Secretary, Craig McNab, effective 3 March 2025.



Exploration

ASX Listing Rule 5.3.1: Exploration and Evaluation Expenditure during the quarter was \$27K.

ASX Listing Rule 5.3.2: There were no mining production and development activities during the quarter.
