## 16<sup>th</sup> Copper Concentrate Shipment Dispatched

**Perth, Australia:** Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 16<sup>th</sup> shipment of copper-gold concentrate from its Al Wash-hi – Majaza copper-gold mine in Oman. The Al Wash-hi – Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL

### Summary

- **16<sup>th</sup> shipment comprising 1395 wet metric tonnes (WMT) of copper-gold concentrate shipped on 26 April, containing 237.9 metric tonnes (MT) of copper and 2.6 Kg gold.**

The Al Wash-hi Majaza copper-concentrate plant achieved production of 1395 WMT of copper-gold concentrate, containing approximately 237.9 MT of copper and 2.6 Kg of gold in its latest shipping cycle. This comprises the 16<sup>th</sup> parcel of copper-concentrate exported from the plant and departed Sohar Port on 26 April 2025.
