INTELCARE EXECUTES COMMERCIAL AGREEMENT WITH MECWACARE TO TRIAL INTELCARE AT TRESCOWTHICK CENTRE IN PRAHRAN

HIGHLIGHTS

- InteliCare executes binding Agreement with mecwacare to trial InteliCare at the Trescowthick Centre ("Trescowthick") in Prahran, Victoria
- mecwacare is a not-for-profit, leading provider of aged care and disability services in Victoria operating 22 aged care facilities (providing care to more than 1,600 residents), six retirement villages, three affordable housing locations and four community and disability service centres (providing care and support to 18,600 clients)
- mecwacare has begun a digital transformation in how it will offer and manage care into the future, with the goal to become the leading technology enabled care provider in Victoria
- mecwacare is deploying the InteliCare solution at the Trescowthick Centre as part of mecwacare's digital strategy and ongoing commitment to innovation and enhancing the experiences of residents, clients and staff
- The trial period will run for three months once the InteliCare solution has been fully installed at the Trescowthick Centre at the end of which, if the trial has been successful, mecwacare will make a decision about further deployment across its residential aged care facilities
- This initial agreement includes \$212k for hardware and implementation services

Headline terms for the Agreement include:

- Deployment of IntelliCare across the whole Trescowthick Centre facility (60 residents).
- Total expected Hardware and Implementation fees of \$212k (ex-GST).
- The deployment will begin immediately.
- Three month assessment period once fully installed.
