Rey Resources Limited (ASX: REY) (“Rey” or “the Company”) is focused on developing its oil and gas interests in the Canning and Perth Basins, Western Australia.

## 1. Oil and Gas

### 1.1 Fitzroy Blocks (EP457 and EP458)

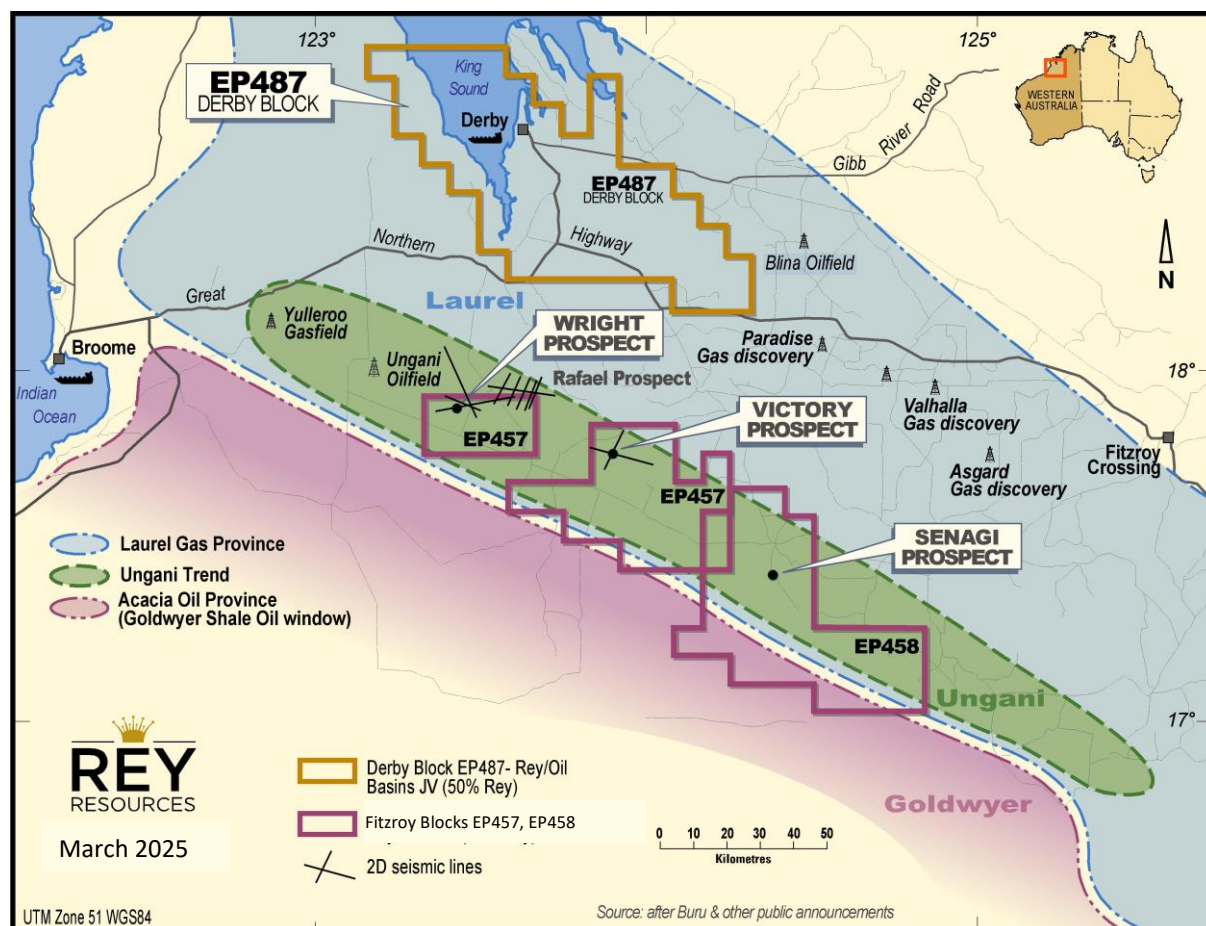


Figure 1: The three major prospective trends relative to Fitzroy Blocks EP457 and EP458 and Derby Block EP487

The Fitzroy Blocks are located in the Canning Basin in the northwest of Western Australia (refer Figure 1 below).

For EP458 following the surrender application, Rey is discussing with the department for further action.

For EP457, the Operator has lodged a work variation application to have a 2D seismic reprocessing work program done before any other proposed work program which would include further new seismic or drilling.

### 1.2 Derby Block (EP487)

The Company currently holds a 100% interest in petroleum exploration permit EP487, the Derby Block, via its 100% owned subsidiaries Rey Lennard Shelf Pty Ltd and Rey Derby Block Pty Ltd.

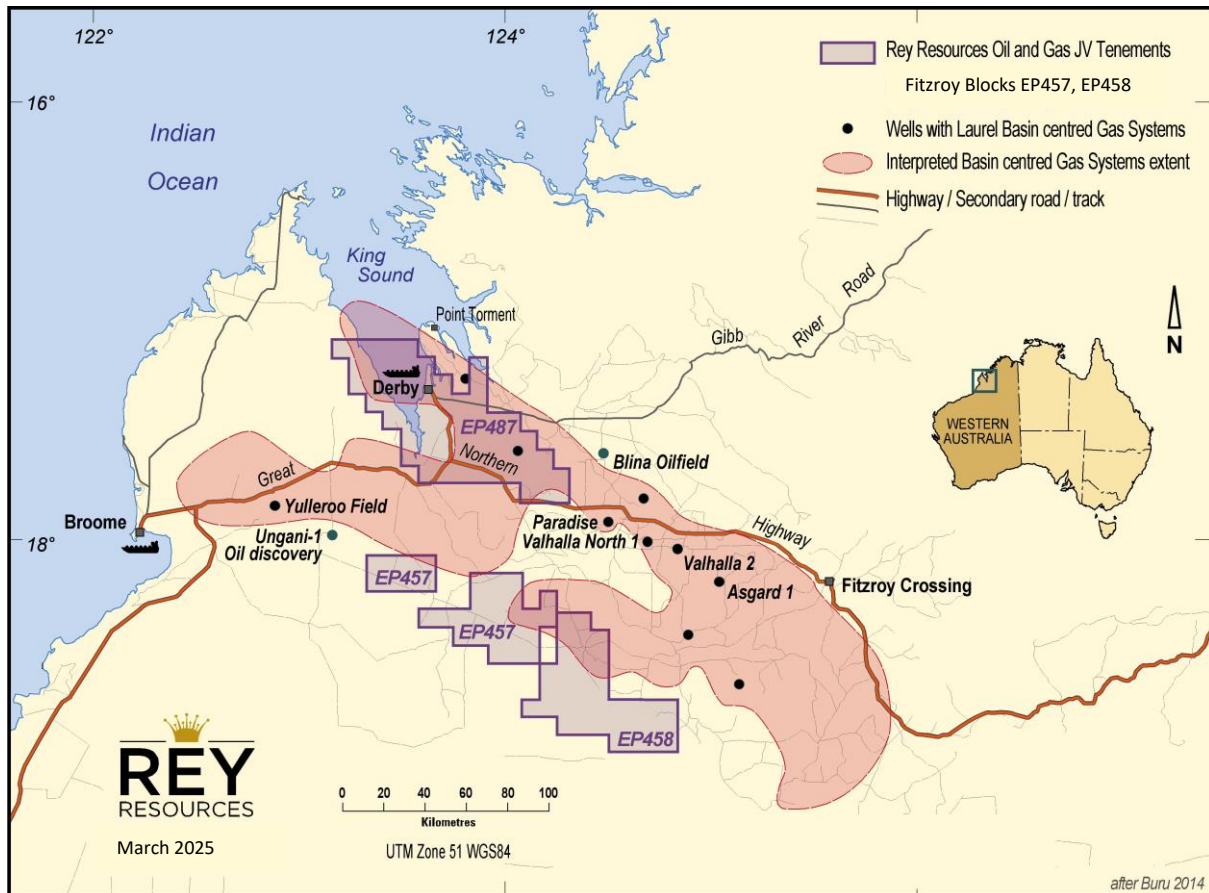


Figure 2: Interpreted extent of the Laurel Basin gas system in relation to Rey's petroleum interests (after Buru and others).

The Derby Block is considered to be predominantly a Wet Laurel Basin Centred Gas (BCG) play which is regionally extensive throughout the Canning Basin (refer to Figures 2 below) and has been the subject of exploration elsewhere in the Canning Basin by other parties in 2015, resulting in encouraging flow tests by Buru at Valhalla and Asgard.

During this quarter, Rey is actively contacting with Native Title holders and landowners for the land access for the proposed 3D Seismic survey. Rey also is working with consultant for the update of EP487 3D seismic environmental plan.

## 2. Coal

The Duchess Paradise Coal Project (**DP Project**) is a proposed bituminous thermal coal operation located in the Canning Basin of Western Australia and is partly contiguous with the Fitzroy Blocks.

Comments have been received from the Native Title Holder for the Protocol. Rey is reviewing the changes and will comment on the Protocol.

## 3. Corporate

As at the quarter ended 31 March 2025, the Company maintained a cash balance of \$52,000 and available loan facilities from Ms Wanyan Liu and ASF Group Limited of \$4.39 million and \$2 million respectively.

As required pursuant to section 6 of the Company's Appendix 5B, the Company paid approximately \$48,460 to related parties during the quarter, of which \$18,900 were consulting fees and \$29,560 were Director fees.
