

Extract of the Investment Management Agreement (Agreement) between Ruffer LLP (Investment Manager) and Waystone Management (UK) Limited (WML) (the authorised corporate director of WS Ruffer Gold Fund (Fund))

- 2.4 **Voting Rights:** The Investment Manager may request that the Depositary exercise all voting and other powers and discretions relating to the Assets, although it is not obliged to do so.
