## DY6 to commence exploration in Cameroon


DY6 Metals Ltd (ASX: DY6, "DY6" or "Company") is pleased to announce that the Company will shortly commence exploration at the Douala Basin and Central Rutile projects in Cameroon.

The Company's technical team, lead by Cliff Fitzhenry, has identified high priority areas for immediate exploration at the Central Rutile project, which adjoins Peak Mineral's (ASX:PUA), Minta Rutile Project. Initial exploration will consist of detailed mapping and soil sampling on a wide-spread grid basis to ensure maximum coverage across the ~2,100km² licence area.

Technical Consultant, Cliff Fitzhenry, commented: "We have secured the services of a highly-regarding Cameroonian consultancy which, in addition to having prior experience with Eramet at the Company's Douala Basin project, has a deep understanding of the prospective locations across the Central Rutile project area. Importantly, they are well resourced and equipped to shortly commence first-pass exploration across both projects.

"I am looking forward to getting on the ground in Cameroon in early June. With the extraordinary results recently announced by Peak Minerals, we are even more excited about the potential for natural rutile discoveries across our own projects."

At the Douala Basin project, the Company intends to commence an auger drilling programme. The Diwong licence was previously known as the Missole Project was held by the French multinational Eramet. Eramet drilled some 60 sonic holes on the Project for 1,080m (582 samples) with 39 hand auger holes for 190m (39 samples) specially targeting rutile and zircon. The drilling intersected thick sequences of sands and confirmed the presence of rutile and zircon within the valuable heavy mineral assemblage.

The Company is fully funded to undertake these initial exploration programs.
