Issue of cleansing notice under section 708A(5)(e)(i) of the Corporations Act 2001 (Cth)

This notice is given by Aurum Resources Limited ("AUE" or the "Company") under section 708A(5)(e) of the Corporations Act 2001 (Act).

Further to the Appendix 2A released today, a total of 3,962 fully paid ordinary shares (**Shares**) were issued as a result of the conversion of MKG options as per the takeover documentation.

Secondary Trading Notice Pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Act)

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, a sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

Pursuant to sections 708A(5)(e) and 708A(6) of the Act, the Issuer gives notice that:

- a) the Shares were issued without disclosure to investors under Part 6D.2 of the Act;
- b) as at the date of this notice, the Issuer has complied with:
 - I. the provisions of Chapter 2M of the Act, as they apply to the Issuer; and
 - II. section 674 of the Act; and
- c) as at the date of this notice, other than as set out below, there is no information that is 'excluded information' within the meanings of section 708A(7) and 708A(8) of the Act.
