

Keybridge Capital Limited (**Keybridge**) holds a relevant interest in 214,095,014 ordinary shares in its subsidiary, Yowie Group Ltd (**Yowie**).

The directors that Keybridge, Yowie, and HHY had in common were removed as directors of Keybridge on 10 February 2025. As has been notified to Yowie previously, Keybridge intends to call a meeting to replace the directors of its subsidiary Yowie and has served various notices on Yowie.

Following Yowie's announcement on 12 May 2025 of a placement of 15% of its total issued capital placement to wholesale investors, Keybridge's:

- relevant interest in Yowie **increased** from 78.34% to 81.17%; however
- ability to cast votes at Yowie shareholder meetings **decreased** from 66.78% to 58.07%.
