

Tony Rovira appointed Executive Director

Solara Minerals Ltd (ASX: SLA) (**Solara** or the **Company**) is pleased to announce the transition of highly regarded and experienced mining executive Tony Rovira from his role as Non-Executive Director of the Company to the position of Executive Director, effective 1 June 2025.

Termination	Either the Company or Mr Rovira may terminate Mr Rovira's engagement as an Executive Director at any time for any reason by giving 1 months' written notice.
