Shareholders will have the opportunity to submit questions during the Meeting.

The Notice is important and should be read in its entirety. If you are in doubt as to the course of action you should follow, you should consult your financial adviser, lawyer, accountant or other professional adviser.

Please note, the Chair intends to vote **IN FAVOUR** of Resolutions 5 to 7 and **AGAINST** Resolutions 1 to 4, unless the Shareholder has expressly indicated a different voting intention.
