MEETING WITH MINISTER OF FINANCE AND PROJECT SITE VISIT

Titanium Sands Limited ("TSL" or "the Company") is pleased to provide the following update on its Mannar Heavy Mineral Project (The Project) in Sri Lanka.

Directors of TSL and Orion Minerals recently presented at the Ministry of Finance, Planning and Economic Development along with other mineral sands stakeholders in Sri Lanka. In attendance were the Geological Survey and Mines Bureau (GSMB), the Board of Investment (BOI) along with approx. 14 further parties.

The meeting was called by the Minister himself with a request "to elaborate on specific challenges or issues being experienced by mineral excavation projects in Sri Lanka". Titanium Sands Director Jason Ferris presented on behalf of The Company and outlined the frustrations and delays the Project had encountered, however also focused on the future, and where the Ministry could aid in streamlining the approval process.

Further, a site visit was undertaken at Mannar Island where approx. 24 landowners and community representatives were hosted at the Orion project office at Mannar (*Image 1*). The discussions were civil and focused on timing and the causes of delays on the Project, many already outlined at the Ministers meeting.

Finally, a meeting with the Environmental Impact Assessment (EIA) team was very productive and confirmed the environmental studies were on track with various consultants focused on specific items raised in the Terms of Reference (TOR) issued in March this year¹.

Titanium Sands Director Jason Ferris said "The Government of Sri Lanka appear focused on creating and generating a significant Heavy Mineral industry. By calling this meeting, they have shown they are proactive in finding solutions to boost the economy. It really feels like a positive step forward for the country and the Project.

Separately, the site visit to Mannar and having the opportunity to meet with landowners was an opportune time to further explain the benefits of the Project to the community members present. Including the significant employment and financial benefits to the community during mining, the proposed rehabilitation post mining will create income and job creation for generations to come".

The Company will provide further updates as available.
