GOLD RC DRILL PROGRAM COMMENCES AT SALT CREEK

HIGHLIGHTS

- Commencement of 1,000m RC drill program focusing on high-priority gold targets across Omnia's Salt Creek Project, north-east of Kalgoorlie
- Drill program focusing on untested gold drill targets identified at Salt Creek Project
- Drill targets were identified following geophysical survey acquisition and independent review of gravity and magnetics datasets¹
- The Salt Creek Project covers a total of 223km² of land across the Goldfields, in a region that is highly prospective for gold, copper, and nickel

Omnia Metals Group Ltd ("Omnia" or the "Company") (ASX: OM1) is pleased to announce the commencement of a 1,000m Reverse Circulation ("RC") drill program focusing on high-priority gold targets across its Salt Creek Project, north-east of Kalgoorlie.

OMNIA METALS EXECUTIVE CHAIRMAN, PATRICK GLOVAC, SAID:

"The commencement of drilling at Salt Creek marks an exciting step forward for Omnia as we target high-priority gold anomalies in a proven mineral province.

"The program is underpinned by high-quality geophysical interpretation and supported by strong technical foundations. With approvals in place and targets defined, we look forward to rapidly advancing exploration and delivering meaningful results for our shareholders."

GOLD DRILL TARGETS




Figure 1: Planned RC Collars at Omnia's Salt Creek Project (EL28/3149)

The RC drill program consists of seven RC drill holes focussed on untested high-priority gold targets geophysical survey acquisition and independent review of gravity and magnetics datasets (see Figure 1). The program is expected to be completed within a week.




Figure 2: Historical auger assays showing gold and copper anomalies at E28/3149 in the Goldfields

Southern Geoscience Consultants completed modelling and interpretation work on data from one of the Exploration Licences (E28/3149) (see Figure 2).

Omnia completed a Heritage Survey at the Salt Creek Project with the Upurli Upurli Native Title Group ("UUNAC"). The Heritage Survey was performed to ensure there would be no impact on the traditional lands of the Upurli Upurli people by the approved Program of Work ("PoW") to complete up to a RC drill program. Last year, Omnia submitted a Heritage Impact Notice ("HIN") that detailed the PoW to the UUNAC. Omnia received a response to the HIN that the Company has approval to complete drilling following completion of the Heritage Survey.
