Dr. Alex Alonso Joins Singular Health Group as U.S. Radiology Advisor and Leads Clinical Trial at Life Radiology FL

With more than 20 years of experience in diagnostic imaging, Dr. Alonso will provide strategic input into the development of SHG's 3DICOM software, ensuring alignment with the needs and standards of U.S. radiologists.

In addition to his role with SHG and PNS, Dr. Alonso will deploy the 3DICOM solution at Life Radiology FL, a diagnostic centre he founded that operates in Doral, Florida. Life Radiology FL has a full range of advanced imaging services - including MRI, CT scans, X-rays, ultrasounds, mammograms, serving the South Florida population of over 7 million people.

The use of the 3Dicom solution at Life Radiology FL will support early diagnostic workflows, and involve PACS integration, secure image sharing, and patient access tools. SHG is supporting these efforts by contributing integration and marketing costs.

Together, Dr. Alonso's advisory role under PNS and the independent Life Radiology FL deployment represent key steps in SHG's expansion into the U.S. national market, combining clinical validation with onthe-ground expertise to shape a radiology imaging solutions platform built for real-world impact.

The engagement with Dr Alonso has a 6-month duration. Singular will issue Dr Alonso (or his nominee) USD\$27,000 in Singular fully paid ordinary shares calculated using the 14-day VWAP at the end of the 6-month engagement period in lieu of payment of a consulting fee to Dr. Alonso, further aligning the consultants' interests with those of shareholders of the Company.
