Notice Under Section 708A(5)(E) of the Corporations Act

The Directors of HyTerra Ltd (**ASX: HYT**) (**HyTerra** or the **Company**) provide a notice for the purposes of section 708A(5)(E) of the Corporations Act 2001.

The Company has issued 500,000 fully paid ordinary shares (Shares) pursuant to the Appendix 2A lodged with ASX 30 June 2025 and issued 26,858,000 fully paid ordinary shares (Shares) pursuant to the Appendix 2A lodged with ASX 1 July 2025. The shares are part of a class of securities quoted on ASX and may be subject to a subsequent offer for sale.

The Company issued the securities above without a disclosure document to investors under Part 6D.2 of the Corporations Act 2001 (Cth) (the Act).
