The Performance Rights will vest into Shares upon the Company's undiluted market capitalisation being equal or greater than A\$200,000,000 for 20 consecutive trading days (based on the volume average weighted price of shares for each trading day during that period) at any time prior to the Expiry Date (31 March 2026). For the avoidance of doubt, this corrects section 15.1 of the notice of meeting released on 3 July 2025 which incorrectly noted a market capitalisation of A\$250,000,000.
