#### **Entitlement Offer Closing Date Reminder**

### **Highlights**

- \* Partially Underwritten Entitlement Offer scheduled to close on Monday, 14 July 2025 at 5pm (Sydney time).
- \* Directors, Brett Smith and Neale Edwards subscribed for their full entitlement under the Entitlement Offer and Mark Edwards subscribed for \$11,668 worth of Shares under the Entitlement Offer.
- \* APAC Resources subscribed to their full entitlement and shortfall to reach Voting Power in the Company of up to 32.55%. Depending on the level that other Shareholders subscribe for their Entitlements, this may require a scale-back.
