- **Three-month trial of InteliCare at mecwacare's Trescowthick Centre in Prahran, Victoria has commenced;**

- Smartphone based 'Alarms delivery and response' for care staff, as an improvement over simple DEC phone messages;
- Austco Nurse Call Connector – Providing an Integrated solution for managing and tracking Alarms across the facility, incorporating Call Bell, Falls, Vitals, and Location Based Alarms in one system;
- Fridge Temperature Monitoring and Reporting - This feature has automated a manual task providing temperature logging as well as alerting should a medication or food refrigerator temperature fall outside set thresholds.

Through the use of IntelliCare's real-time time data monitoring and predictive analytics, we are really excited to be able support mecwacare in exploring how they can use this information to enhance resident care through tailored health and well-being plans."
