## **Strategic Capital Raise Completion, Options Exercise and Cleansing Statement**

**Nanoveu Limited (ASX: NVU) (“Nanoveu” or the “Company”)**, a technology innovator across advanced semiconductor, visualisation, and materials science, is pleased to announce that the Strategic Placement announced on 11 July 2025 has settled, raising \$2.0 million (before costs) through the issue of 36,363,637 fully paid ordinary shares at \$0.055 per share. This placement was completed under the Company’s existing placement capacity under ASX Listing Rules 7.1 and 7.1A. Additionally, the Company has issued 384,615 ordinary shares following the exercise of unlisted options (Exp 31/12/2026, exe \$0.05).
