Subsequent to the quarter end, on 2 July , the Company entered into an unsecured short term loan with Argonaut Partners Pty Ltd of \$750,000 as part of sale agreement relating to the Company's 17.5% interest in the Greater Duchess JV. The Loan has establishment fee of \$30,000 and has interest payable of 1% per month commencing from 1 October 2025. The loan is repayable on the earlier of - the completion of the JV interest sale, - termination of the non-binding term sheet - termination of any agreement entered into for purposes of giving effect to sale of JV Interest - event occurring in respect of the pre-emptive rights that may cause a condition precedent to the sale of JV interest becoming incapable of being satisfied. - or 12 months from date of agreement.

Answer:

On 2 July 2025, the company announced the sale of non-core interest in Greater Duchess Gold JV with cash consideration of \$2m on completion. The transaction provides the Company with near term, non-dilutive funding which will enable the Company to continue advancing its Finnish and Western Australian assets.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, the Company does expect to be able to continue its operations and meet its business objectives based on level of planned exploration activities. Future exploration activities will be targeted and cost effective to be funded from working capital ensuring commitments are being met. Should additional funding be required, the Directors are confident that funds can be secured through future funding options.
