Moses is a specialist in mineral exploration, resource evaluation and project management. He has more than 20 years' experience in the minerals and mining industry and has held senior management roles with several mining companies in a number of African countries, as well as in Australia.

Moses has been directly responsible for the discovery and development of several major African mineral deposits including Shanta Gold's Luika gold deposit in Tanzania, the Mokopane iron and vanadium deposits in South Africa for Bushveld Minerals, and the Imaloto coal deposit in Madagascar for Lemur Holdings. He also made significant contributions to the discovery and development of several other mineral deposits, including Rum Jungle Uranium's one billion tonne Ammaroo phosphate deposit in Australia's Northern Territory.

As a Cameroonian national Moses completed his schooling and BSc degree within Cameroon before moving to South Africa where he completed his BSc Honours and MSc degrees from Wits University, as well as a PhD in geology from the University of Johannesburg and an MBA from Wits Business School. Moses is a Registered Professional Natural Scientist with the South African Council for Natural Scientific Professions (SACNASP) as well is a Fellow of the Geological Society of South Africa (FGSSA).

Moses previously served as Exploration Manager for Luso Global Mining in Cameroon and Angola and also acted as a Consulting Technical Adviser for Chilwa Minerals Ltd in Malawi. From 2012 to 2015 he served as Business Development Geologist for Africa Middle East Resources (AMER) in Conakry, Guinea.

Troth has been with the Company since September 2023 and over the last two years has been managing the Company's Malawian project portfolio and local operations.

Corné Coetser, who has been consulting to the Company over the past couple of months, will transition to the role of Senior Exploration Geologist while the Company's Malawian based geologist, Geoffrey Banda, has been promoted to Project Geologist, Africa. Prior to joining DY6 in 2024, Geoffrey was a Junior Geologist for Sovereign Metals Ltd in Malawi, where he received broad exploration experience at the world-class Kasiya Rutile deposit.

With the addition of Moses and Corné to the team, DY6 is well-positioned to rapidly expand exploration activities at the Company's Central Rutile Project, Cameroon.
