

## PROSPECTUS OFFER OPENS FOR LOYALTY OPTIONS

Lodestar Minerals Limited (**ASX:LSR**) (**Lodestar** or **the Company**) is pleased to advise it has lodged the prospectus for the Company's bonus issue of loyalty options to Eligible Shareholders (**Prospectus**)

The Company announced on 30 June 2025 it would be providing Eligible Shareholders a non-renounceable pro-rata bonus issue of options (**New Options**) on the basis of one (1) New Option for every thirty (30) Shares held on the Record Date.

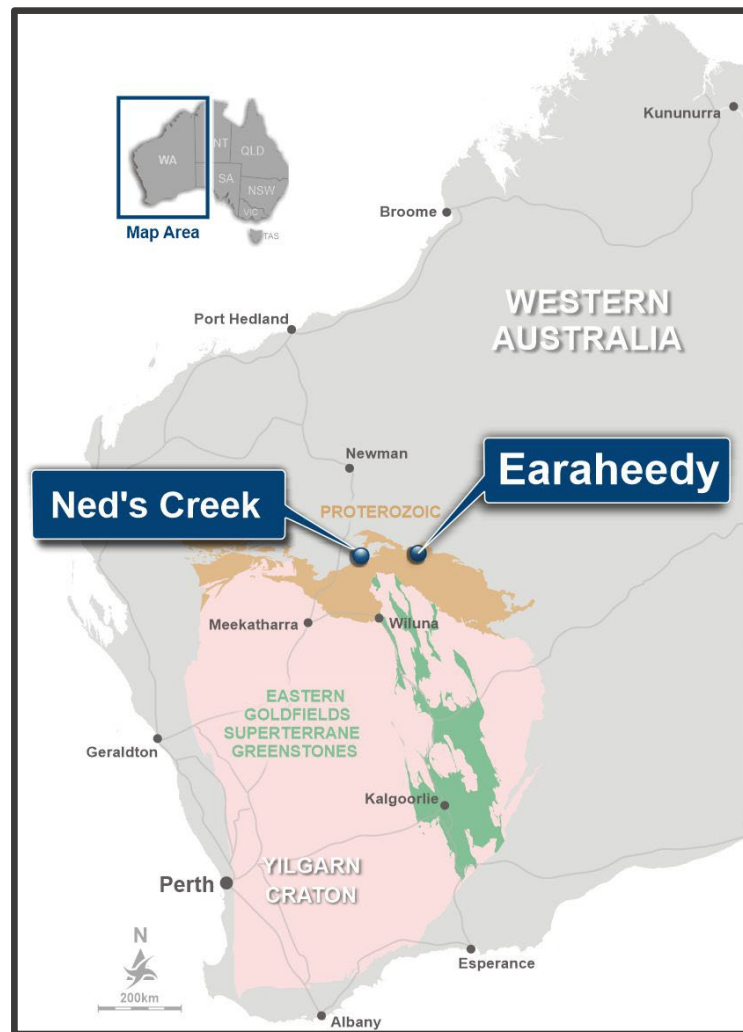


Figure: Lodestar's WA Project locations
