

## **CONCRETE SLAB POURED AT SUBANTANDO FERTILIZER PLANT**

Minbos Resources Limited (ASX:MNB) ("Minbos" or the "Company") is pleased to announce a key construction milestone in the development of its Subantando Fertilizer Plant in Angola, with the successful pouring of concrete for the plant's main structural slab (Fig.1).

This achievement marks a significant step forward in the construction schedule and reflects the continued momentum of the Cabinda Phosphate Project as the Company progresses towards commissioning and production.

• Structural works are now in a position to commence once funding for phase 2 is finalised, including fabrication and erection of the steel framework and installation of plant equipment.

Minbos remains focused on completing construction in line with its development schedule, with first production targeted for 2026.

Further updates on construction progress and project milestones will be provided in due course.

**About Minbos:** Minbos is developing a nutrient business in Angola establishing customer relationships with distributors and food aggregators and providing education to commercial and family farmers through extension services. The Cabinda Phosphate Project will supply the Primeiro product to address the phosphate deficiency in Angolan soils. The Fertiafrica partnership will supply granulated Primeiro+ products (NPKS). The Capanda Green Ammonia project will produce nitrogen for the Primeiro+ products. Minbos aims to link Angolan farmers with inputs and markets to make Agriculture bigger than Oil.
