

Cleansing Notice

Brazilian Critical Minerals Limited (**ASX: BCM**) ("**BCM**" or the "**Company**") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the **Act**') that on 12 August 2025, it has issued 252,425,353 fully paid ordinary shares in the capital of the Company at an issue price of \$0.008, as tranche 2 of a placement approved by shareholders.

 - i. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - ii. the rights and liabilities attaching to the Shares.
