

## COURT APPROVES CONVENING OF SCHEME MEETING AND RELEASE OF SCHEME BOOKLET

Gold Road Resources Limited (**Gold Road** or the **Company**) is pleased to provide this update in relation to the proposed acquisition of 100% of the shares in Gold Road by Gruyere Holdings Pty Ltd (**GHPL**), an entity ultimately owned by Gold Fields Limited (**Gold Fields**), by way of a scheme of arrangement (**Scheme**).

### Court Orders

Today, the Supreme Court of Western Australia (**Court**) made the following orders in relation to the Scheme:

- that Gold Road convene a meeting of its ordinary shareholders (**Scheme Meeting**) to consider and vote on a resolution to approve the Scheme; and
- that an explanatory statement which includes information about the Scheme (**Scheme Booklet**) be despatched to Gold Road shareholders.

### Scheme Meeting

The Scheme Meeting will be held as a hybrid meeting at **2.00pm (AWST) on Monday, 22 September 2025**. Gold Road shareholders will be able to attend and participate in the Scheme Meeting in person at The Melbourne Hotel, 33 Milligan Street, Perth, WA 6000 or virtually via an online platform which can be accessed at <https://meetnow.global/MRKPFMQ>.

If you are registered on the Gold Road share register as at 7.00pm (AEST) (5.00pm (AWST)) on Saturday, 20 September 2025, you will be entitled to vote at the Scheme Meeting.

All Gold Road shareholders are encouraged to vote either by attending and voting at the Scheme Meeting, or by lodging a proxy vote ahead of the Scheme Meeting. Further details on how to vote will be set out in the Scheme Booklet.

### Scheme Booklet

The Scheme Booklet is expected to be released to ASX on Friday, 15 August 2025 following registration with the Australian Securities and Investment Commission. The Scheme Booklet will provide Gold Road shareholders with important information relating to the Scheme and will also include a copy of an Independent Expert's Report, notice of the Scheme Meeting and instructions about how to vote at the Scheme Meeting.

Gold Road shareholders who have:

- elected to receive electronic communications, or who have not made a communication election but have an email address recorded in the Gold Road share register, will be sent an email containing instructions about how to view and download a copy of the Scheme Booklet, as well as instructions on how to lodge their proxies for the Scheme Meeting online;
- elected to receive communications via post will receive a printed copy of the Scheme Booklet, together with a personalised proxy form; or
- not made a communication election and do not have an email address recorded in the Gold Road share register will receive a letter, together with a personalised proxy form, with instructions about how to view or download a copy of the Scheme Booklet.
