SCHEDULE 1 - TERMS AND CONDITIONS OF NEW HRZ OPTIONS

The terms of the New HRZ Options are:

- 1. Each New HRZ Option entitles the holder to one fully paid ordinary share in HRZ (**Share**) upon exercise of the New HRZ Option.
- 2. The New HRZ Options may be exercised at any time prior to 5:00pm AWST on 21 September 2025 (Expiry Date).
- 3. The exercise price of the New HRZ Options is AU\$0.087 each.
- 4. The New NRZ Options are freely tradeable under Australian law.
- 5. HRZ will provide to each New HRZ Option holder a notice that is to be competed when exercising the New HRZ Options (**Notice of Exercise**). New HRZ Options may be exercised by the New HRZ Option holder in whole or in part by completing the Notice of Exercise and forwarding the same to the Secretary of HRZ to be received prior to the Expiry Date. The Notice of Exercise must, among other things, state the number of New HRZ Options exercised, the consequent number of Shares to be allotted and the identity of the proposed allottee.
