CLARIFICATION – PREVIOUS ANNOUNCEMENT



QMines Limited (ASX:QML)(**QMines** or **Company**) refers to the Company's ASX Announcement dated 12 August 2025 titled 'High-Grade Copper-Zinc Hits Continue at Sulphide City' (**Announcement**).

On page 8 of the Announcement, the following statement was included:

'The revised study will reflect an expanded mine plan (2Mtpa), incorporating blended material from the three projects and updated capital and operating cost estimates.'

A further reference to '2Mtpa' is included on pages 2 and 3 of the Announcement.

These statements are aspirational in nature as a throughput parameter for an ongoing feasibility study, however this disclosure may be interpreted as a production target for the purposes of ASX Listing Rule 5.16 and accordingly, the Company retracts the statements and investors should not rely on the statements in making investment decisions.

In this context, the Company looks forward to the results of its ongoing studies at its 100% owned Mt Chalmers, Develin Creek and Mt Mackenzie projects as upcoming milestones advised in the Announcement.

QMines Limited (ASX:QML) is a Queensland focused copper and gold exploration and development Company. The Company owns 100% of the Mt Chalmers (copper-gold) and Develin Creek (copper-zinc) deposits, located within 90km of Rockhampton in Queensland.

Mt Chalmers is a high- grade historic mine that produced 1.2Mt @ 2.0% Cu, 3.6g/t Au and 19g/t Ag between 1898-1982.
