

Funding Pathway Secured to Complete Cinovec DFS; A\$3m Placement and Non-Dilutive Refinancing

Highlights

- €11.0m Geomet cash call issued to fund completion of the Cinovec DFS; EMH share €5.39m (~A\$9.67m), due 10 October 2025.
- A\$3.0m placement completed; proceeds applied to EMH's cash-call obligation and EMH working capital.
- Non-dilutive balance planned via refinancing CZK 121m (~A\$8.86m) Dukla loan and/or sale of surplus Dukla land.
- DFS on track following additional test work indicating potential reagent and waste reductions; with completion target of October 2025.

European Metals Holdings Limited (ASX & AIM: EMH, OTCQX: EMHXY/EMHLF) (“European Metals” or the “Company”) advises that Geomet a.s. (the Cinovec project company) has issued a €11.0 million cash call (the Cash Call) to fund completion of the DFS. Under the project ownership structure of which, EMH's share is €5.39 million (~A\$9.67 million) with Severočeské Doly (CEZ) to contribute €6.61 million. The Cash Call is payable by 10 October 2025.

To support its payment, the Company has completed a placement of approximately A\$3.0 million (before costs) to high net worth and institutional clients of Barclay Wells and Zeus Capital. Proceeds will be applied toward EMH's Cash Call payment and general EMH working capital.

In parallel, EMH intends to refinance the CZK 121 million (~A\$8.86 million) Dukla loan that EMH advanced to Geomet in 2023 for the acquisition of land at Dukla, originally contemplated as the site of the Lithium Chemical Plant. Given the proposed plant relocation to Pruněřov, most Dukla land is no longer required. Consistent with EMH's strategy to minimise shareholder dilution, the Company is progressing refinancing and/or partial or full asset sale options. Negotiations are advanced and EMH expects completion in time to meet its Cash Call obligations.

Executive Chairman Keith Coughlan said: “The Geomet cash call is a key step in completing the DFS and keeping Cinovec on its critical path. We have acted quickly to secure A\$3 million and are pursuing non-dilutive funding for the bulk of the cash call via the Dukla loan refinance and potential land sale. With additional test work indicating further flowsheet improvements and potential reagent and waste reductions, we remain focused on delivering the DFS in October 2025 and closing the value gap between EMH's market capitalisation and the project's fundamentals.”

Placement details

18.75 million ordinary shares at an issue price of A\$0.16 per share to raise A\$3 million (before costs).

The issue price of \$0.16 represents a 20% discount to the Company's last traded price on 15 August 2025 (A\$0.20).

The Shares and DI's are expected to settle on Friday, 22 August 2025 and commence trading on a normal basis on Monday, 25 August 2025. New shares issued under the Placement will rank equally with existing shares on issue.

The Placement has been conducted pursuant to the Company's existing Placement capacity under ASX Listing Rule 7.1.

Barclays Wells acted as Lead Manager and Bookrunner to the Placement.

Cinovec DFS update

DFS workstreams are progressing, with tunnel kiln evaluation, bulk materials handling studies and additional roasting test work indicating scope for reagent and waste reduction in the flowsheet. The DFS remains targeted for completion in October 2025.

BACKGROUND INFORMATION ON CINOVEC

PROJECT OVERVIEW

Cinovec Lithium Project

Geomet s.r.o. controls the mineral exploration licenses awarded by the Czech State over the Cinovec Lithium Project. Geomet has been granted a preliminary mining permit by the Ministry of Environment and the Ministry of Industry. The company is owned 49% by EMH and 51% by CEZ a.s. through its wholly owned subsidiary, SDAS. Cinovec hosts a globally significant hard rock lithium deposit with a total Measured Mineral Resource of 53.3Mt at 0.48% Li₂O, Indicated Mineral Resource of 360.2Mt at 0.44% Li₂O and an Inferred Mineral Resource of 294.7Mt at 0.39% Li₂O containing a combined 7.39 million tonnes Lithium Carbonate Equivalent (refer to the Company's ASX/ AIM release dated 13 October 2021) (**Resource Upgrade at Cinovec Lithium Project**).

An initial Probable Ore Reserve of 34.5Mt at 0.65% Li₂O reported 4 July 2017 (**Cinovec Maiden Ore Reserve – Further Information**) has been declared to cover the first 20 years mining at an output of 22,500tpa of lithium carbonate (refer to the Company's ASX/ AIM release dated 11 July 2018) (**Cinovec Production Modelled to Increase to 22,500tpa of Lithium Carbonate**).

This makes Cinovec the largest hard rock lithium deposit in Europe and the fifth largest non-brine deposit in the world.

Cinovec has been designated a Strategic Project by the European Union under the Critical Raw Materials Act. (refer to the Company's ASX/ AIM release dated 25/26 March 2025) (**Cinovec declared a Strategic Project under EU Critical Raw Materials Act**) and a Strategic Deposit by the Czech Government (refer to the Company's ASX/ AIM release dated 7 March 2025) (**Cinovec declared Strategic Deposit by Czech Government**).

The deposit has previously had over 400,000 tonnes of ore mined as a trial sub-level open stope underground mining operation.

On 19 January 2022, EMH provided an update to the 2019 PFS Update. It confirmed the deposit is amenable to bulk underground mining (refer to the Company's ASX/ AIM release dated 19 January 2022) (**PFS Update delivers outstanding results**). Metallurgical test-work has produced both battery-grade lithium hydroxide and battery-grade lithium carbonate at excellent recoveries. In February 2023 DRA Global Limited ("**DRA**") was appointed to complete the Definitive Feasibility Study ("**DFS**").

Cinovec is centrally located for European end-users and is well serviced by infrastructure, with a sealed road adjacent to the deposit, rail lines located 5 km north and 8 km south of the deposit, and an active 22 kV transmission line running to the historic mine. The deposit lies in an active mining region.

The Cinovec processing plant comprises of a Front-End Comminution and Beneficiation circuit ("FECAB") and Lithium Chemical Plant circuit ("LCP") in combination producing Lithium Hydroxide or Lithium Carbonate end products and will be located on the Prunéřov 1 Power Station site located approximately 59km by rail from the Cinovec mine site. (refer to the Company's ASX/ AIM releases dated 26 April 2024 (**New Lithium Plant Site Expected to Improve Project Permitting and Economics**) and 27 November 2024 (**Cinovec Project Update**)).

The economic viability of Cinovec has been enhanced by the recent push for supply security of critical raw materials for battery production, including the strong increase in demand for lithium globally, and within Europe specifically, as demonstrated by the European Union's Critical Raw Materials Act (CRMA).

BACKGROUND INFORMATION ON CEZ

Headquartered in the Czech Republic, CEZ a.s. is one of the largest companies in the Czech Republic and a leading energy group operating in Western and Central Europe. CEZ's core business is the generation, distribution, trade in, and sales of electricity and heat, trade in and sales of natural gas, and coal extraction. The foundation of power generation at CEZ Group are emission-free sources. The CEZ strategy named Clean Energy for Tomorrow is based on ambitious decarbonisation, development of renewable sources and nuclear energy. CEZ announced that it would move forward its climate neutrality commitment by ten years to 2040.

The largest shareholder of its parent company, CEZ a.s., is the Czech Republic with a stake of approximately 70%. The shares of CEZ a.s. are traded on the Prague and Warsaw stock exchanges and included in the PX and WIG-CEE exchange indices. CEZ's market capitalization is approximately EUR 20.3 billion.

As one of the leading Central European power companies, CEZ intends to develop several projects in areas of energy storage and battery manufacturing in the Czech Republic and in Central Europe.

CEZ is also a market leader for E-mobility in the region and has installed and operates a network of EV charging stations throughout Czech Republic. The automotive industry in the Czech Republic is a significant contributor to GDP, and the number of EV's in the country is expected to grow significantly in the coming years.

LITHIUM CLASSIFICATION AND CONVERSION FACTORS

Lithium grades are normally presented in percentages or parts per million (ppm). Grades of deposits are also expressed as lithium compounds in percentages, for example as a percent lithium oxide (Li_2O) content or percent lithium carbonate (Li_2CO_3) content.

Lithium carbonate equivalent ("**LCE**") is the industry standard terminology for, and is equivalent to, Li_2CO_3 . Use of LCE is to provide data comparable with industry reports and is the total equivalent amount of lithium carbonate, assuming the lithium content in the deposit is converted to lithium carbonate, using the conversion rates in the table included below to get an equivalent Li_2CO_3 value in percent. Use of LCE assumes 100% recovery and no process losses in the extraction of Li_2CO_3 from the deposit.

Lithium resources and reserves are usually presented in tonnes of LCE or Li.

The standard conversion factors are set out in the table below:
