Firebrick Secures \$1.4 million via Placement

Firebrick Pharma Limited (ASX:FRE) (**Firebrick, Company**) is pleased to announce that it has secured firm commitments from investors for approximately \$1.4 million through the issue of 22,222,222 new fully paid ordinary shares ("**Shares**") at an issue price of \$0.063 (6.3 cents) per share (the "**Placement**").

The Company previously undertook a fundraising seeking \$1.6 million in June 2025 via a placement through Report Card Pty Ltd ("**RC Placement**") but raised only \$0.2 million, leaving a shortfall of \$1.4 million (announcement 26 June 2025). The current Placement secures that \$1.4 million shortfall and allows the following projects to proceed as planned:

- Expanding Nasodine® Nasal Spray (**Nasodine**) sales in the US market;
- Expanding Nasodine distribution and marketing in Singapore and its launch in other South-East Asian markets during FY2026; and
- Funding the final development and manufacturing of up to three new Nasodine-brand products for launch into all available markets in FY2026.

Investors in the Placement were introduced by an existing shareholder in Firebrick. There were no broker or adviser fees or other material costs associated with the Placement.

The key terms of the Placement were the same as those offered in the RC Placement, including the offer price of Shares, the ratio of options provided, and the strike price and expiry date for the options.

Details of the Placement:

The 22,222,222 million Shares will be issued pursuant to the Company's existing placement capacity under ASX Listing Rules 7.1 and 7.1A. The Shares to be issued represent approximately 9.7% of current shares on issue (227,321,695). The issue price of \$0.063 per share represents a discount of 18.3% on the 15-day VWAP to 22 August 2025 (\$0.0771).

Placement participants will receive one free attaching option (**Option**) for every two Shares issued (11,111,113 Options), with an exercise price of \$0.095 (9.5 cents) and an expiry date of 4 July 2028. Terms and Conditions of the Options are attached.

The Options will be issued pursuant to the Company's existing placement capacity under ASX Listing Rule 7.1. The Shares and Options are expected to be issued on or around 1 September 2025.

TERMS AND CONDITIONS OF OPTIONS

1.	Entitlement	Subject to paragraph 12, Each Option entitles the holder to subscribe for one Share upon exercise of the Option.
2.	Exercise Price	Subject to paragraph 9, the amount payable upon exercise of each Option will be \$0.095 (Exercise Price).
3.	Expiry Date	Each Option will expire at 5:00 pm (AEST), 4 July 2028 (Expiry Date). An Option not exercised before the Expiry Date will automatically lapse on the Expiry Date
4.	Exercise Period	The Options are exercisable at any time on or prior to the Expiry Date (Exercise Period).
5.	Exercise Notice	The Options may be exercised during the Exercise Period by notice in writing to the Company in the manner specified on the Option certificate (Exercise Notice) and payment of the Exercise Price for each Option being exercised in Australian currency by electronic funds transfer or other means of payment acceptable to the Company.
6.	Exercise Date	An Exercise Notice is only effective on and from the later of the date of receipt of the Exercise Notice and the date of receipt of the payment of the Exercise Price for each Option being exercised in cleared funds (Exercise Date).
7.
