## Completion of Drill Programme

**Patriot Resources Limited** (“Patriot”, “PAT” or the “Company”), provides an update on its ongoing exploration activities in Zambia.

The drill programme has been shortened and is now completed and samples are being prepared and despatched for assay.

The Company will now refocus our exploration efforts mainly at Katwaro and the potential NW/SE mineralisation extensions previously discovered and announced.

**Commenting on the drill program, Patriot Chairman, Mr Hugh Warner, stated** “As previously announced, it was disappointing that the Sugarloaf option agreement was terminated following due diligence. Part of our initial interest in the Sugarloaf deposit was the opportunity to generate early cashflows, based on historic testworks. Unfortunately, our independent testworks on more than 1 tonne (bulk) mineralised ore, was unable to replicate similar recoveries.

Sugarloaf was an opportunistic pivot that we thought worth pursuing, given the historic data presented, which didn’t pay off.

Our small team will now refocus our exploration work at the Katwaro Pit and the extensions which have previously yielded strong copper mineralisation, including:

- in the Katwaro Pit, high grade assays of 1.16% Cu and 0.68g/t Au over 14m; including *4.45% Cu and 2.59g/t Au over 2m<sup>1</sup>*
- To the NW, in the Broken Hill pits, high grade results from pXRF of up to 17.36% Cu<sup>2</sup>

Patriot remains well funded to pursue its existing opportunities and to assess further exploration prospects.”

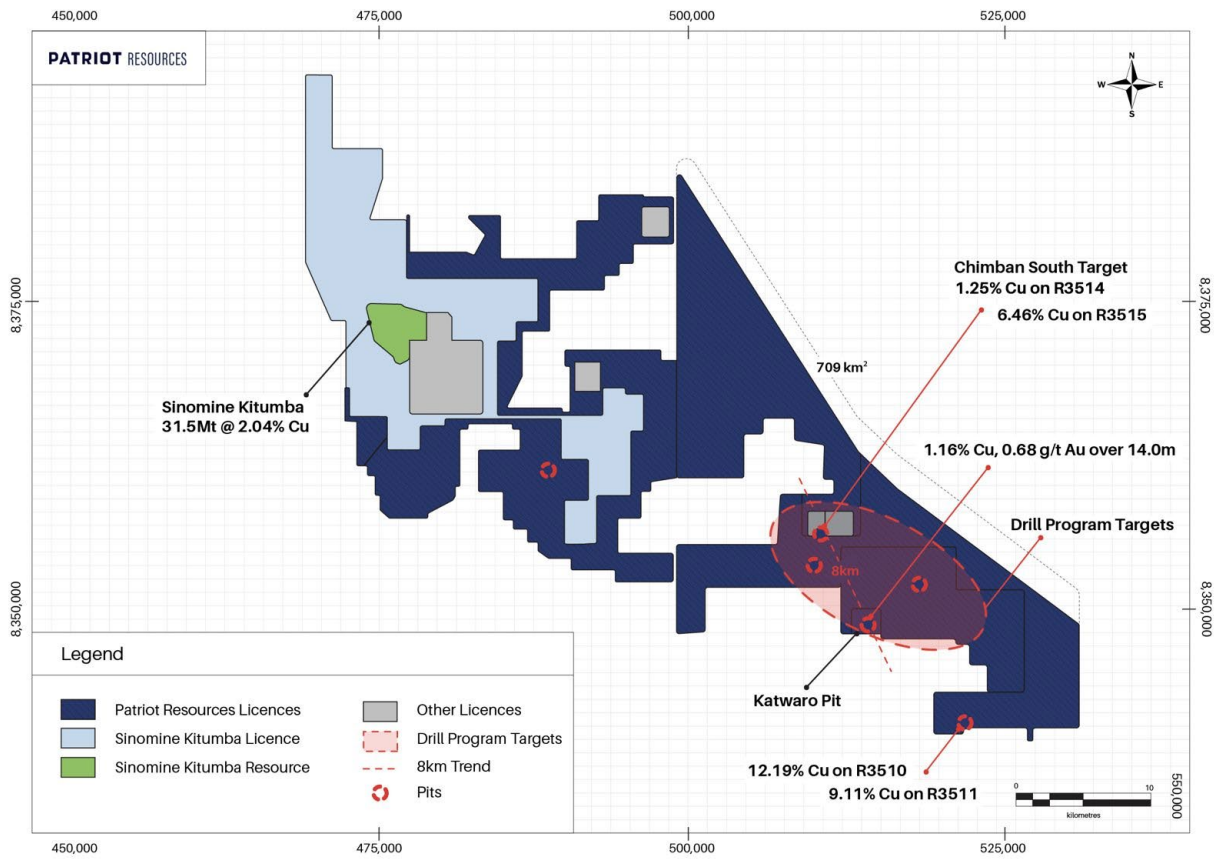


Figure 1 – Patriot's current licences
