

## Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Brazilian Critical Minerals Limited (ASX: BCM) ("BCM" or the "Company") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the Act') that on 28 August 2025, it has issued 122,590,580 fully paid ordinary shares in the capital of the Company as announced on 28 August 2025.
