# REPLACEMENT - LANDED AT LAST CONTINUES TO GROW WITH BONANZA GRADES FROM RE-SPLITS AT THE F1 PROSPECT

Arika Resources Limited (ASX: ARI) ("Arika" or "Company") advises that on 3 September 2025 it released an announcement titled "Landed at last continues to grow with bonanza grades from re-splits at the F1 prospect" ("Announcement").

Arika now releases a replacement version of the Announcement incorporating minor edits and the inclusion of Table 2 with the drillhole collar information and tabulation of significant intercepts for the holes drilled at Great Bonaparte East.

# LANDED AT LAST CONTINUES TO GROW WITH BONANZA GRADES FROM RE-SPLITS AT THE F1 PROSPECT

Plus, strike extensions confirmed in initial drilling at nearby Great Bonaparte East Prospect

# **KEY HIGHLIGHTS**

# F1 Prospect, Landed at Last

- **Exceptional grades returned** from final single metre re-splits of previously reported composite samples. Final significant intercepts now include:
  - o 3m @ 47.1g/t Au from 53m (25AYRC007), including:
    - 1m @ 130g/t Au from 53m (junction of F1 and Landed at Last)
  - o 22m @ 1.34g/t Au from 20m (25AYRC017), including:
    - 1m @ 8.98g/t Au from 27m
  - o 6m @ 2.02g/t Au from 30m (25AYRC012), including:
    - 4m @ 2.92g/t Au from 31m, and
    - 1m @ 9.40g/t Au from 33m
- The results confirm the quality of mineralisation at F1 and highlight the opportunity for bonanza grades to occur at the junction of gold-bearing structures throughout the Yundamindra Project.
- F1 is one of several structures which cross-cut the Landed at Last lode in the Western Corridor at Yundamindra towards the northern end of the 'Yellow Brick Road' a 16km+ long structural corridor with numerous high-grade historical workings.

# **Great Bonaparte East (GBE)**

- New significant intercepts returned from step-out drilling at GBE, located 600m south of Landed at Last, include:
  - o 26m @ 1.19g/t Au from 88m (25AYRC022), including:
    - 11m @ 2.44g/t Au from 98m; and
    - 1m @ 21.95g/t Au from 103m
  - 10m @ 0.53g/t Au from 33m (25AYRC019)
  - o 1m @ 2.29g/t Au from 17m (25AYRC018)
  - o 16m @ 0.36g/t Au from 52m (25AYRC020)
  - o 7m @ 0.53g/t Au from 101m (25AYRC023)
- The GBE ore-hosting structure shows increasing thickness and grade at depth and may represent a strike extension of the mineralisation discovered at Landed at Last.
- Drilling continues at Yundamindra, testing multiple, high-grade gold targets including Banjo's Camp, Queen of Poland and Golden Treasure Deeps.

Arika Resources Limited (ASX: ARI) ("Arika" or "Company") is pleased to provide an update on exploration results and drilling activities at the **Yundamindra Gold JV Project**, located 65km south-west of Laverton in the world-class Northeastern Goldfields mining district of WA

Arika launched a ~10,000m drilling campaign in June following the Company's successful ~\$5 million capital raise in May 2025. The aim of this program is to test and define the depth and strike extents of the multiple known gold occurrences and newly defined targets throughout the Yundamindra and Kookynie project areas.




Figure 2: Zoom in of the northern section of 'The Yellow Brick Road', Western Corridor.

Drilling initially re-commenced within the **Western Corridor** at the **F1 Prospect**, comprising 17 Reverse Circulation (RC) holes for 1,856m of drilling (25AYRC001-25AYRC017). Refer Figures 2-4 and Table 1.

Step-out exploration drilling then progressed to Great Bonaparte East (**GBE**), located 600m south of the F1 Prospect, and comprised seven RC holes for 680m of drilling (25AYRC018-25AYRC024). Refer to Figures 2, 5, 6 and 7 and Table 2.

Preliminary assays for the F1 Prospect drilling were reported in early August<sup>1</sup> and included numerous intervals sampled as 4 metre composites, while the results from the final holes remained pending at that time.

All of the 4 metre composite samples were re-split into single 1 metre samples and re-submitted for analysis. This release provides a full summary of the final assays for all samples relevant to the F1 program (25AYRC001-25AYRC017) and for seven holes drilled to test strike and depth extensions at Great Bonaparte East (25AYRC018-25AYRC024).

The F1and Great Bonaparte East Prospects are both located towards the northern end of the 'Yellow Brick Road' – a strongly mineralised structural corridor which extends for more than 16km along the western flank of the Yundamindra Syncline.

The F1 Prospect is the first to be drill tested of a series of structures identified from aeromagnetic geophysical data that cross-cut the Landed at Last lode. Preparations for systematic, first pass drill testing targeting further high-priority structures at F2, F3 and F4 are currently underway.

The Great Bonaparte East (GBE) Prospect is defined by a cluster of old underground workings centred on the interpreted southern strike extension of the Landed at Last gold-hosting structure.

The drilling described in this release at GBE focussed on testing for depth and strike extensions in the immediate vicinity of the old workings and well beyond previous drilling.

Arika has also commenced wide spaced drill testing of the area between Landed at Last and Great Bonaparte East, a highly prospective part of the structural trend has never been previously drilled and represents a high priority target area for Arika.

The Western Corridor is defined by two major NW-SE trending structures, with numerous NE-SW linking faults. Both the NW-SE and NE-SW fault orientations carry significant gold mineralisation and can be traced continuously under areas of cover for hundreds of metres. However, previous work has only focused on shallow oxide ore around the known historical workings with limited to no drilling having ever been undertaken to test for depth or strike extensions.

Arika's current campaign is designed to test for depth and strike extensions beyond the known limits of the previously reported intersections and to provide a first pass test of a number of new high priority targets defined by a combination of geological, geophysical and geochemical characteristics.


# Arika's Managing Director, Justin Barton, said:

"The Landed at Last-F1 gold system has considerable scale and is getting bigger with each stage of drilling. Our drilling continues to identify multiple gold lodes with significant widths and impressive high-grade zones, as evidenced by these latest results from the 1m re-splits at the F1 Prospect.

"The mineralisation at Landed at Last is continuous over at least 800m of strike and 200m down-dip and remains open. F1 is the first of several cross-cutting structures to be tested and these impressive results demonstrate the quality of the mineralisation and significant gold endowment of the system.

"Meanwhile, Great Bonaparte East is one of multiple, historical workings which sit on the same structure that hosts Landed at Last, or the parallel structures to it, and which have never been tested at depth or along strike. Drilling is continuing at pace to test new targets and to extend and expand beyond previous results.

"We look forward to providing further updates and drill results as this exciting phase of our exploration continues."


Prospect Location plan showing recent drilling and proposed holes over simplified geology and TMI.

# **Drilling Results Summary - F1**

A detailed summary of the geology and mineralisation of the F1 Prospect was presented in Arika's ASX Announcements dated 08 April and 11 August 2025. Figure 3-4 and Table 1 present a drillhole location plan , Vertical Longitudinal Projection and Summary of Significant Intersections now updated with final assay results.

The holes were designed to test the targeted primary structures orthogonal to strike and based on current interpretation true widths are estimated to be approximately 60% of the down-hole intercepts for most of the holes noting local variations in dip and strike.








Figure 4: F1 Prospect: Schematic Vertical Longitudinal Projection (F1-Fault local grid) with recent final assay results and historical drilling.

# **Drilling Results - Great Bonaparte East (GBE)**

Seven holes were drilled at Great Bonaparte East along six sections spaced 40m apart and were designed to test for extensions to the known mineralisation at least 40-80m beyond the historical intercepts over a strike length of about 180m.

Most holes completed to date have reported wide zones of moderate gold mineralisation with narrow higher grade internal zones and/or gold anomalism within the targeted intervals.


As has been observed elsewhere along the Western Corridor, gold mineralisation is typically hosted within strongly hematite and potassic altered quartz monzodiorite, commonly associated with thin quartz veins and magnetite destruction.

The country rock at GBE is completely to highly weathered medium to coarse grained equigranular biotite rich granitoid. Variations in the country rock occur through deformation and alteration within and proximal to shear zones.

Drilling to date at GBE has confirmed the presence of a single gold-bearing shear zone displaying a moderately arcuate shape in plan view dipping gently at about 45 degrees towards the Northeast. Arika's latest drilling at GBE has now confirmed the presence of gold mineralisation continuously over a strike length of at least 180m and to at least 120m down-dip below surface.

The zone of mineralisation remains open along strike and at depth.

Figures 5, 6 and 7 present a Drillhole Location Plan, Schematic Vertical Longitudinal projection and Schematic Cross-Section respectively.




Figure 6: Great Bonaparte East Prospect: Schematic Vertical Longitudinal Projection (GBE local grid) with recent assay results and historical drilling.




Figure 7: Great Bonaparte East: Schematic Cross-Section Line 1000mN (F1 local grid) with recent assay results.

# **Next Steps**

# Yundamindra

- > RC drill testing of new targets across the Yundamindra Project area is continuing.
- Wide-spaced sectional drilling is currently in progress at Banjo's Camp/Queen of Poland/Golden Treasure Deeps.
- > Results will be released continuously once data is received and interpreted.
- ➤ Data collected from a drone-supported aeromagnetic survey recently completed over the southern half of the Yundamindra Project area, along with results from ultra-detailed aeromagnetic and ground gravity surveys undertaken at Pennyweight Point, are currently being assessed by the Company's geophysical consultants, Core Geophysics.
- > The results from this work will be used to further refine target selection prior to drilling.

# Kookynie

- Data from a drone-supported aeromagnetic survey completed at the Ithaca Prospect adjacent to Genesis Minerals' Ulysses Gold Project is currently being assessed by Core Geophysics.
- > DHEM surveys of purpose drilled RC holes at McTavish is in progress to assess the electrical signature of iron sulphides associated with gold mineralisation. Possible direct ore finding technique in areas of surficial cover if electrical continuity is confirmed.
- The results from this work will be used to further refine and prioritise targets for planned drill testing in the coming weeks.

# **Yundamindra Gold Project**

The Yundamindra Gold JV Project is located 65km south-west of Laverton, 250km north of Kalgoorlie, Western Australia (Figure 5). The Project is a Joint Venture between Arika Resources Ltd (ASX: ARI) and Nex Metals (ASX: NME), where Arika holds 80% and NME holds 20% with Arika acting as Project manager.

Regionally, it is situated toward the westernmost margin of the Laverton Greenstone Belt (LGB) in the Yilgarn Craton of Western Australia.

The Laverton Greenstone Belt is one of the best endowed gold regions in Australia. It hosts two world-class producing mines, namely Sunrise Dam at 8 million oz contained Gold and Wallaby at 7 million oz contained gold (Standing 2008; Austin, 2022)<sup>2</sup>, which are located just ~20-30km east of Arika's Yundamindra Gold Project. Total gold production from the belt is estimated to be in excess of 28 million ounces.

The Laverton Greenstone Belt is one of a number of greenstone belts that collectively define the Kurnalpi tectonostratigraphic terrane of the Northeastern Goldfields 'Superterrane'.

The Kurnalpi Terrane is bounded by the regionally recognisable Hootanui Shear Zone to the east and the Ockerburry Shear Zone to the west – long-lived, deep crustal/mantle penetrating structures which, along with their related second order faults, are considered responsible for the development of many of the region's most significant gold deposits.



At the local scale, the Yundamindra Project covers both the south-western and south-eastern flanks and the southern nose of a regional scale synformal fold comprising a central hornblende-granodiorite batholith which intruded mafic-felsic and lesser sedimentary lithologies (Figure 1 and 2).

This style of structural setting is commonly associated with the development of many of the region's most significant gold deposits. Although the area has had a long history of prospect-scale mining, it has not been subjected to systematic modern exploration and remains under-explored, particularly at depth.

This presents ARI with a unique opportunity to discover significant mineralisation near a number of processing facilities.

# **Appendix One - Significant Intercepts and Collars**

Significant intercepts in the table below were calculated on a length weighted average basis.

Each RC hole drilled by Arika was sampled in its entirety from start to finish using a combination of 2m or 4m composites and 1m individual samples. For diamond drillholes the diamond cored section of each hole was sampled in its entirety from the start of each cored section to end of hole with sampling guided by geological observations and maximum sample lengths generally not exceeding 1m.

For the low-grade envelope this was based on a 1m sample returning an assay value of greater than 0.1 g/t Au and for the high-grade zone, based on internal intervals reporting assays greater than 0.5 g/t Au, 5.0g/t Au and 10.0 g/t Au respectively. The maximum width of internal waste was generally 4m however the mineralised intervals are based on geological observations and current interpretation. Consequently, in some instances a broader interval of internal waste, interpreted as a 'horse' of limited dip and strike extent may be carried in order to honour the true nature of the ore hosting structure as defined by adjacent drillholes at that location.

No top cut-off was applied due to the early nature of the assessment.


