# CHANGE TO FINAL DIRECTOR'S INTEREST NOTICE

Richmond Vanadium Technology Limited ("**RVT**" or the "**Company**") advises that a correction has been made to the Appendix 3Z – Final Director's Interests lodged on 30 June 2025 for Ms Lingli (Lily) Zhao

The original Appendix 3Z omitted a transaction involving 3,211 ordinary fully paid shares, released from escrow on 13 December 2024, held indirectly through a related party, Ms Jinru Liu. At the time of release, of these Unmarketable Parcels as per the Buy Back on 24 April 2025, these shares were acquired by the Company which should have triggered disclosure by way of an Appendix 3Y.

Due to this administrative oversight, the Appendix 3Z lodged on 30 June 2025 was incomplete. An updated appendix 3Y has now been submitted and the corrected Appendix 3Z, which now includes the additional disclosure, is attached.

Upon identification of the omission, the Company acted promptly to rectify the matter in accordance with Listing Rule 3.19A. The Company has re-briefed all directors on their disclosure obligations under Listing Rules 3.19A and 3.19B and section 205G of the Corporations Act 2001 (Cth). In addition, the Company has reviewed its Securities Trading Policy and strengthened its internal compliance checks to prevent recurrence to include reconciliation checks and registry reporting cross-matching

The Company confirms that this oversight does not impact any other market disclosures made under Listing Rule 3.1 or section 674 of the Corporations Act.

The Board is confident that the arrangements it currently has in place are adequate and doesn't believe that any additional steps are required to ensure ongoing compliance with listing rule 3.19B.
