# Asra Minerals Completes Rebranding and Commences Trading as GoldArc Resources (ASX:GA8)

# **Highlights**

- The Company's name change from Asra Minerals Ltd to Gold Arc Resources Ltd is now complete
- Trading will commence under the new ticker GA8 effective today
- 10-for-1 consolidation of the issued capital is complete, resulting in a more effective and appealing capital structure
- Completion of \$3.2 million placement
- Rebranding concludes a strategic initiative to align the Company's identity with its clear focus on gold exploration within the highly prospective geological 'arc' of the Eastern Goldfields

**GoldArc Resources Ltd (ASX:GA8) ("GA8" or "GoldArc" or "the Company")** (formerly Asra Minerals Limited, ASX:ASR) is pleased to advise that, following shareholder approval obtained at the General Meeting held on Thursday 27<sup>th</sup> August 2025, the Australian Securities and Investments Commission (ASIC) has formally registered the change of the Company's name to GoldArc Resources Limited.

The Company will commence trading on the Australian Securities Exchange (ASX) under the new ticker code **GA8** effective today. In conjunction with the name change, the previously announced 10-for-1 consolidation of capital has been completed.

The new name has been chosen to clearly communicate the Company's primary objective: to make new discoveries and grow its resource base within the strategic geological corridor connecting its key gold projects in the Leonora and Kookynie districts of Western Australia.

## **GoldArc Resources Managing Director, Paul Stephen, commented:**

"Today marks a significant and exciting milestone for the Company and its shareholders. The transition to GoldArc Resources, with our new ticker GA8, is more than just a name change; it's a clear statement of our strategy and commitment to becoming a leading Australian gold explorer.

The name GoldArc defines our operational focus on the highly prospective geological 'arc' that hosts our projects, while the consolidated capital structure provides a stronger platform for future growth and is designed to be more compelling to institutional and long-term investors.

With this strategic rebranding now complete, we are better positioned than ever to accelerate our exploration programs and unlock the immense value of our Western Australian gold assets. We look forward to updating the market with results from our ongoing drilling campaigns under our new identity as GoldArc Resources."


