

COMPANY RE-CAPITALISATION

ASX Announcement | 4 NOVEMBER 2016



Australian oil and gas company TTE Petroleum Ltd (ASX: TTE) (TTE or the Company) continues to effectively manage its cash flow in the current environment and as part of the re capitalisation of the Company it has reduced the convertible note debt by \$671,666 by the conversion of convertible notes and the redemption of convertible notes for cash. The Board continues to implement a strategic cash management program.

TTE Petroleum Ltd has redeemed for cash 221,666 convertible notes of \$1.00 each expiring on 31 October 2017. The convertible notes were redeemed at their face value of \$1.00 each.

Following the conversion and redemption, TTE Petroleum Ltd has the following securities on issue:

1,227,535,191 ordinary shares

126,387,613 options expiring on 30 May 2020

143,678,160 options expiring on 31 May 2020

1,325,000 convertible notes expiring on 31 October 2017
