RESULTS OF 2016 ANNUAL GENERAL MEETING OF SHAREHOLDERS

The Directors of Manhattan Corporation Limited wish to advise that the two Resolutions as per the Notice of Meeting were passed on a show of hands at the Annual General Meeting of shareholders held in Perth on Friday 4 November 2016.

In accordance with listing rule 3.13.2 and section 251AA of the *Corporations Act 2001* the following information is provided:

1. Resolution 1: Adoption of Remuneration Report

Valid proxy votes received in relation to ordinary non binding Ordinary Resolution 1:

- (i) 47,658,243 proxy votes in total;
- (ii) 11,036,939 votes in favour of the Resolution;
- (iii) No votes against the Resolution; and
- (iv) 36,621,304 votes excluded or abstained from voting.

2. Resolution 2: Re election of John A G Seton as a Director

Valid proxy votes received in relation to Ordinary Resolution 2:

- (i) 47,658,243 proxy votes in total;
- (ii) 47,558,243 votes in favour of the Resolution;
- (iii) No votes against the Resolution; and
- (iv) 100,000 votes abstained from voting.
