Regal Resources Ltd (ASX: RER) (the "Company" or "Regal") advises that, in accordance with the Company's Employee Share Option Plan that was approved by shareholders on 30 June 2016 ("ESOP"), Regal's Board of Directors have resolved to issue a collective pool of 45 million unlisted options exercisable at 1.42 cents per option to its new Chief operating officer ("COO") (refer announcement on 31 October 2016) and new Chief financial officer ("CFO") (refer announcement dated 1 November 2016), effective 14 November 2016.

The options will vest equally over a three year period. All approved options vest on a change of control transaction.
