SRG AWARDED \$24.4M CONTRACT FOR KEEPIT DAM UPGRADE PROJECT IN NSW

Highlights

- SRG awarded \$24.4M contract with WaterNSW for posttensioning works of Keepit Dam Upgrade Project located near **Tamworth in NSW**

SRG Limited (ASX:SRG) ("SRG"), a leading complex services company, is pleased to announce that it has been awarded a Schedule of Rates with Lump Sums contract with WaterNSW valued at \$24.4M for the specialist dam anchoring works on the Keepit Dam Upgrade Project located near Tamworth in NSW.

Under the contract, SRG will complete all works required for the installation of post-tensioned cable anchors in the concrete section of the existing dam. The works are to begin in the first quarter of 2017 and are expected to be completed in two years.

SRG Managing Director, David Macgeorge stated, "We are very pleased to have been awarded this contract for the specialist dam anchoring works on Keepit Dam. SRG has a long history of successfully delivering dam strengthening projects with the installation of world record capacity ground anchors."

"This significant project sees SRG's Civil Division and Mining Division's Geotech services coming together to deliver an end to end solution to WaterNSW. SRG are looking forward to working closely with WaterNSW to successfully deliver this important infrastructure project."

Keepit Dam was originally designed in the 1930's and completed in 1960. It is situated on the Namoi River about 40 kilometres upstream of Gunnedah on the north west slopes of the NSW Northern Tablelands. The dam has a capacity of 425,000 megalitres, making it nearly as large as Sydney Harbour.
