Completion of Maiden Lake Roe RC drilling programme, all results pending

Carnavale Resources Limited ("CAV" or "the Company") is pleased to announce completion of the Lake Roe RC drilling programme at the Stag Prospect. Samples have been submitted to the laboratory and are expected in approximately 2 weeks.

The Stag drilling is targeting gold mineralisation hosted in a second order southeast trending structure, as defined in magnetics and earlier limited drilling. This structure splays off the major regional north south shear zone that hosts the nearby ASX listed Breaker Resources' Bombora Lake Roe gold discovery approximately 10km to the south.

The Stag Prospect RC drilling programme comprised 12 completed holes for a total advance of 1,360m. The drilling intersected varied and highly weathered clays, chlorite schists, dolerite and volcaniclastic sediments under approximately 40m of transported material. Drilling conditions prevented two holes reaching the proposed depth and two additional proposed holes were not drilled based on information at the time.

Encouragingly, five of the completed holes intersected quartz veining in chloritic schists with disseminated pyrite in one of the holes. Samples have been submitted to the laboratory with results pending.
