The Company advises that it has today issued a total of 134,109,769 Fully Paid Ordinary Shares (ASX code: NSL) as a result of the conversion 104,109,769 listed \$0.01 and 30,000,000 unlisted \$0.0096 options in accordance with notices received.

BOARD CONVERSION

Importantly, NSL's Chairman, has provided significant support with the conversion of 15,250,000 \$0.01c and 30,000,000 \$0.0096c options totalling \$440,500. This is in addition to his current substantial investment in the Company, which further underpins the Boards belief and confidence in the Company's strategy going forward.
