Coffs Harbour Health Campus launches Intelligent Cardiovascular Information System (iCVIS)

Alcidion Group Limited (ASX:ALC) in conjunction with FUJIFILM Medical Systems, a division of FUJIFILM Australia Pty Ltd (**FUJIFILM**) has completed the delivery of the leading edge intelligent Cardiovascular Information System (**iCVIS**) to Coffs Harbour Health Campus in NSW, Australia. iCVIS was developed by Alcidion for FUJIFILM and is built upon the Miya platform to address the clinical risk, workflow and logistical issues that are encountered in cardiology departments.

iCVIS, in combination with Synapse CV, is a vendor-neutral scheduling, imaging, and reporting platform for use with all Cardiovascular imaging equipment. It is designed to enhance cardiology care and analysis using smart clinical informatics software, with the specific goals of improving workflows, clinician efficiency and patient safety.

After recent on site effort from both FUJIFILM and Alcidion, the product was successfully validated and put live within the hospital on Tuesday the 25th of October 2016.

The installation of iCVIS will improve operations, with a fully electronic workflow, targeted at managing the services provided by the Cardiology Department at Coffs Harbour. Extensive work was undertaken to fully understand how iCVIS could be customised and applied within the Coffs Harbour environment to provide substantial workflow improvements and efficiency gains.

Mr Ray Blight, Chief Executive Officer of Alcidion said, "Alcidion is very pleased to see FUJIFILM reach a new stage in the commercialisation of this award winning solution. We have now reached a level of maturity that will allow for the rapid rollout of the Intelligent Cardiovascular Information System to the broader market."

Alcidion is excited about achieving an installation of this intelligent cardiovascular technology into a New South Wales Hospital and the successful rapid integration process with the existing state-wide Cerner Patient Administration System. iCVIS and Cerner share a bidirectional interface, by which iCVIS is receiving patient demographics and cardiology orders from Cerner, and sending back order updates and finalised clinical reports and images.

Maura Kelly, the Coronary Investigations Unit Nurse Unit Manager at the Coffs Harbour Health Campus said, "The installation of the iCVIS system here at Coffs Harbour signals a significant improvement in our processes and takes us from a paper based workflow to a fully electronic ordering and reporting solution".
